Headquartered in Maron di Brugnera (Pordenone) **L&S is a leading global player** in the **design and production of bespoke and technological integrated LED lighting systems and solutions** for residential, industrial and commercial applications with revenue of ca Euro 120 million. L&S employs approximately 500 people and operates 6 manufacturing facilities in Italy, Germany, China and US.

Following Clessidra acquisition in 2019, L&S continued and accelerated its successful growth path: reinforced its management team through selected hirings, accelerated innovation of product portfolio, successfully implemented significant operational improvements, reinforced the core residential business with two strategic acquisitions in Italy and strengthened the international development of the business.
